The **Bideha Municipality**,Office of the Municipal Executive **Tinkauriya , Dhanusha** invites **online bids only under e-procurement system** from eligible bidders for the **Mushar Basti Nirman** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- **Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 61.00Million (without VAT).**
  - **Minimum Work experience of similar size and nature: Construction of at least (2) Project of Government Building Contract within the last ten (10) years, with a value of at least NRs 50 million (without VAT) that have been successfully completed**

Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2074 issued by PPMO which are available in e-GP system.
5. Online bids will be opened in the presence of Bidders' representatives who choose to attend at **13:15hrs on 21th,Mar,2024(B.S. 2080/12/08)** at the office specified above. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs 22,70,000.00 which shall be valid for minimum 30 days beyond the bid validity period i.e. **18th. Jun, 2024 (B.S.2081/03/04)**. The scanned copy of bid security in pdf format should be uploaded in the e-GP system during bid submission.
6. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
